Fall 2012

This year has brought many challenges and opportunities to the Marianna Kistler Beach Museum of Art. Long-serving director Lorne Render retired just before the start of the new fiscal year. His tenure was a period of strengthening and defining the museum as an important cultural resource in the university, the city and the state. The bright future now open to the museum is due in great part to Lorne's ability to live the vision of Ross and Marianna Beach, Ruth Ann Wefald and many, many others.

Lorne's retirement triggered the search that led to my arrival at the start of this year. I can barely find words to describe how privileged I feel to be entrusted with the role of director. I have had and will continue to have a steep learning curve, but I have the assistance of many people who care deeply about the Beach Museum of Art's unique collecting focus on the art of Kansas and the region, as well as its broader programming mission.

In addition to the transition in leadership, the Beach Museum of Art and the membership are facing the departure of another long-serving staffer, Senior Curator Bill North. Bill's knowledge of Kansas art and artists was a valuable resource and his contributions to the museum will not be forgotten.

This year the Beach Museum of Art staff embarked on a strategic planning process. Museums regularly use such structured planning to update mission statements and set strategic goals. In this case the museum employed the services of one of the most respected museum planning and evaluation firms in the nation, Randi Korn & Associates. With the support of Randi and her staff, the Beach team updated the museum's mission statement and developed vision and impact statements. The three statements appear at right. I hope they will provide a context as you read this report on a year in the life of a busy museum -- your museum. Thank you sincerely for your support.

BEACH MUSEUM OF ART ACQUISITIONS

The Kansas State University art collection was begun in 1928 by John F. Helm Jr. Since 1996 many of those artworks entered the permanent collection of the Beach Museum of Art. The collection has grown annually through purchases, donations and bequests, and now totals some 7,000 works. The museum's collection has long emphasized the art of Kansas and the region (the first acquisition was an oil painting by Birger Sandzén), and it continues to do so. As in past years, collection growth is the result of the generous help of donors and the Friends of the Beach Museum of Art. Total fiscal year 2012 acquisitions: 263 (200 gifts). GRANTS RECEIVED

Bramlage Family Foundation: \$5,000

Project period: January - December 2012

Description: This grant will be used to develop curriculum that will help children understand how art connects with science. It supports research and development for K-6 programming using the museum's permanent collection; one year of implementation and evaluation of the new program; and future web-based curriculum available on the museum's website.

Henry Luce Foundation: \$40,000 (total award of \$75,000, balance to be paid in future year)

Project period: December 2012 – November 2015

Project title: The Associated American Artists, 1934-2000

Description: This grant supports the development of an exhibition and accompanying publication that provides the first comprehensive and critical overview of the Associated American Artists, the commercial organization best known as the publisher of prints by Thomas Hart Benton, John Stuart Curry and Grant Wood.

EDUCATION AND PUBLIC PROGRAMS

In the 2012 strategic plan, three target audiences were identified for concentration of effort. They are: university, including students, faculty, staff, alumni and groups; community, the intellectually curious; and school-age children.
